The [National Trust](#) has reopened 130 parks and gardens – tickets are available through advance booking so get out in nature and enjoy the great outdoors as you take on 10k.

Why do we walk?

Because we believe that everyone should have access to justice. In reality, not everyone does. Two-thirds of the UK population don't know how to get legal advice and 14 million people who live in poverty can't afford to pay for it. The COVID-19 pandemic has widened the justice gap further.

Legal advice charities are working tirelessly on the frontline to support individuals and families through this pandemic. Since the beginning of lockdown, agencies have reported a six-fold increase in requests for help as people face urgent issues around housing, employment, Universal Credit, debt, domestic violence and more. People need support to be able to access the justice they are entitled to: whether that is advice about being furloughed, support to challenge an unlawful eviction, or guidance on how to resolve a debt issue. People like Sonia, a client of an advice centre we support:

"Sonia is a 22-year-old victim of trafficking. When she came to us for help, she was 34 weeks pregnant and had just been made homeless. She had been living with a friend in Barnet but the friend asked her to leave because of overcrowding and COVID-19 risks. As she had previously lost a baby, she had specialist perinatal care in Barnet and needed to stay near the hospital. The council offered her emergency

accommodation over 1.5 hours away from the hospital by public transport in another borough. We assisted her in challenging this decision, and they provided her with safe accommodation 20 minutes from the hospital."

Around half of advice agencies nationwide face closure due to the pandemic and resulting loss of funding. A decade of funding cuts, particularly to legal aid, has already forced many centres to close. These surviving advice charities need our support to continue to be a lifeline for their communities.

Every year, the London Legal Walk supports over 100 legal advice services in London and the South East. This year, they need us more than ever. Please help us give everyone access to justice.




